Aura has selected your child(ren)'s school as part of the pilot program for the new AuraPen for education! We believe this will be an exciting new time in education technology.

Thanks for using our products and services ("Services"). The Services are provided by Aura LLC ("Aura"). By using our Services, you are agreeing to these terms for both you and your dependent. Please read them carefully.

Our Services are very diverse, so sometimes additional terms or product requirements (including age requirements) may apply. Additional terms will be available with the relevant Services, and those additional terms become part of your agreement with us if you use those Services.

Using our Services
